Market Vendor Attendance/Cancellation Rules & Fees:

Any Yachats Farmers Market vendor that chooses to NOT attend a Market date that they have indicated to attend on their Yachats Farmers Market application must notify the Market Coordinator **VIA EMAIL ONLY, BY NOON THE FRIDAY BEFORE SUNDAY MARKET** at: YachatsFarmersMarket@live.com

That is **2** days before Market.

This deadline will be enforced, as your space may need to be reassigned to one of our new vendors on our “Floater Vendor List”.

Any Vendor failing to do so and not attending Market will be categorized as a no-show and still be charged the \$30 space fee for their non attended space.

That payment will be collected PRIOR to being able to set up and sell at their next scheduled Market day.

Any Vendor doing a no-show for a 2nd time in the same season will also incur a forfeiture of their next scheduled space date in addition to the \$30 space fee.

Any Vendor doing a no-show for a 3rd time will be penalized again AND be possibly considered for a 12 month ban from the Yachats Farmers Market.
